### **Statutory Regulators told to monitor and enforce laws**

Assistant Director of Public Prosecutions, Dr Andrew Jack, has called on statutory regulators to monitor and ensure legislation put in place is complied with by one and all.

Thirty-seven participants from various government ministries and departments graduated this morning (27.11.20) from a four-week advanced prosecution course for statutory regulators which was designed to equip them in understanding and prosecuting offences under their specific legislation.

Dr Jack said that “Government Ministries and Departments have an important role to play in ensuring that those who flout the laws are brought to court. A country relies on its legislation and there will be new laws passed but they are only effective if regulating bodies continue to do their part and oversee that these laws are adhered to at all times.”

The Office of the Director of Public Prosecutions (ODPP) continues to assist government ministries and departments by providing a series of a training every year to ensure that the people of Fiji receive an efficient and professional prosecution service.

In addition to this, the ODPP provides desk officers to ministries and departments to provide legal advice on the range of possible charges and the evidence required in prosecuting infringements under their own specific legislation.

Next year, the ODPP will be continuing regulatory training as well as offering intensive training to Police investigators.

The course was facilitated by ODPP Principal Legal Officer Mr Yogesh Prasad. All participants were awarded certificates of participation with eight participants receiving special awards.
