CHIEF JUSTICE ADRESSES THE 2nd ANNUAL NATIONAL PROSECUTION COURSE

The Office of the Director of Public Prosecutions (ODPP) successfully concluded its 2nd Annual National Prosecution Course (NPC) this afternoon (28.07.16) by honouring the 24 Police and Statutory Prosecutors during a Graduation Ceremony held at Suvavou House in Suva.

The Chief Justice His Lordship Mr Anthony Gates and the Commissioner of Police Brigadier General Sitiveni Qiliho presented awards and certificates to the participants on their successful completion of the six-week course. The NPC is part of the ODPP's continuing education programme for prosecutors from the Police, government Ministries, Departments, and statutory bodies. Permanent Secretaries from the Civil Service, Employment, and Fisheries were in attendance as well as family members and friends of the graduates.

While congratulating the prosecutors on their graduation the Chief Justice challenged them to continually improve and hone their skills and further their education as prosecutors.

"There is a lot of hard work to be done as prosecutors and if you are not prepared to do hard work, then prosecution is not for you and secondly you have to master your job thoroughly," he said.

He also advised prosecutors to refrain from getting involved in politics.

"As prosecutors who have prosecutorial functions, keep out of politics; if you

want to be a politician go and do something else".

The National Prosecution Course was an intensive course run by the ODPP from

27 June 2016 to 28 July 2016.

There were 24 prosecutors and law enforcement agents attending from the Fiji

Police Force, Fiji National Provident Fund, National Occupational Health and

Safety Services, Ministry of Fisheries, Water Authority of Fiji, Suva City Council

and the Land Transport Authority.

Principal Legal Officers Seini K. Puamau and Yogesh Prasad were the Course

Conveners and they were also assisted by State Counsel from the ODPP

throughout the six week course.
